Terms and Conditions:

 - b. She will draw all parts of pays and allowances in local currency;
 - c. There will be no financial relation with NIB or the Government of the People's Republic of Bangladesh;
 - d. All expenses of the said course will be borne by University International Postgraduate Award (UIPA), University of New South Wales (UNSW), Sydney, Australia;
 - e. She will not be allowed to stay abroad more than the approved period;
 - f. After completing her PhD degree, she shall be working in NIB for a minimum of 5(five) years;
 - g. She will draw her pay and allowances as per National Institute of Biotechnology (officers and Employees) Employment Regulations, 2011;
 - h. She will have to submit awarded certificate and a report to the Biotechnology cell of the Ministry of Science and Technology after completion of the program within 5days after her return from the course ;
 - i. The provision of Higher Education Policy 2015 will be applicable in connection of this approval.
 - j. She will start her journey for Australia on a convenient time near to 12 September 2022.
 - k. She will have to submit awarded certificate to Ministry of Science and Technology within 01 (one) year after completion of the program.
